SUNDAY PULPIT SUPPLY Compensation

A congregation should reimburse a pulpit supply person at the rate of \$135 for a single worship service; each additional worship service should be compensated at a rate of \$35.

If a class/adult forum is taught on Sunday another \$30 should be added.

Mileage should be paid at the IRS approved rate of 57.5 cents per mile driven for business use (down one half of a cent from the rate for 2019)

17 cents per mile driven for medical or moving purposes, down three cents from the rate for 2019, and

14 cents per mile driven in service of charitable organizations.

In the event the pulpit supply person is asked to preach at two separate congregations on the same day, each congregation shall be responsible for appropriate reimbursement.
